great place to live.


The urban forest is managed as **an essential asset** for Banyule and decisions

Principles are the rules and beliefs governing Banyule behaviour and management of the Urban Forest

This principle relates to the vital services that the urban forest provides - fresh air, clean water, shade, cooling, habitat - to the community, while also emphasising that the urban forest needs to be managed as a resource and embedded in asset management processes and policies and accounted for across departments

This principle refers to Council and community working side by side to plan for design and manage greening and trees across private and public lands

This principle relates to the idea of sustainability and intergenerational equity. It is about using the best available information and the best governance structures and decision-making processes that deliver the vision for Banyule.

This principle is about focusing the efforts of urban forest strategy on the specific places and their people across Banyule. It will make sure that decisions are based on a range of evidence about the local places and their differing needs, that there is equity of urban forest access across the Banyule LGA. It is about making the urban forest fit for people and place now and into the future.
